BYLAW NO 10-2013

A BYLAW TO PROVIDE FOR THE MUNICIPALITY TO ENTER INTO AN AGREEMENT TO FORM A DISTRICT BOARD OF REVISION WITH THE MEMBERS OF THE TWIN LAKES PLANNING DISTRICT


The Council of the Rural Municipality of Moose Range No. 486 in the Province of Saskatchewan enacts as follows:

1. This bylaw shall be referred to as the District Board Of Revision Agreement
2. In this bylaw:
 - a. "Administrator" shall mean the administrator of the municipality;
 - b. "Council" shall mean the council of the municipality;
 - c. "Head of council" shall mean the mayor or reeve of the municipality, as the case may be;
 - d. "Municipality" shall mean the Rural Municipality of Moose Range No. 486;
3. The Rural Municipality of Moose Range No. 486 is hereby authorized to enter into an agreement with
 - The Town of Nipawin
 - The Town of Choiceland
 - The Town of Carrot River
 - The Village of White Fox
 - The Village of Codette
 - The Resort Village of Tobin Lake
 - The Rural Municipality of Nipawin No. 487
 - The Rural Municipality of Torch River No. 488for the purpose(s) stated within the agreement.

4. The agreement is attached hereto and forms a part of this bylaw, and is identified as "Exhibit A".

5. The head of council and the administrator are hereby authorized to sign and execute the agreement described as Exhibit A.

**(TWIN LAKES) DISTRICT BOARD OF
REVISION AGREEMENT**

**Pursuant to Sections 220 thru 222
of
*The Municipalities Act***

Twin Lakes District Board of Revision Agreement

MADE IN DUPLICATE THIS 17th DAY OF JANUARY, 2013.

BETWEEN:

The Town of Nipawin

The Town of Choiceland

The Town of Carrot River

The Village of White Fox

The Village of Codette

The Resort Village of Tobin Lake

The Rural Municipality of Moose Range No. 486

The Rural Municipality of Nipawin No. 487

The Rural Municipality of Torch River No. 488

WHEREAS the municipalities hereto voluntarily and collectively intend to establish a DISTRICT BOARD OF REVISION (hereinafter referred to as the "Board"), to hear and decide appeals received, pursuant to Section 226 of *The Municipalities Act* from within the municipalities to this agreement.

The District Board of Revision is being established under the provision of Section 222(1) of *The Municipalities Act*.

COMPOSITION OF THE BOARD

1. Board
 - a) Each party to this agreement may appoint one person to the Board and shall notify the secretary of the Board in writing of their appointment on or before December 31st of each year.
 - b) The Chairperson of the Board shall be designated by the members and the Chairperson may appoint panels of three members to hear appeals. No more than three persons appointed to the Board shall sit, at any one time, to hear appeals.
2. Secretary of the Board
The municipalities hereby agree that Michele Sorensen shall serve as the secretary to the Board.

BOARD'S AND SECRETARY'S REMUNERATION AND EXPENSES

3. Training
The expenses of Board Members and the Secretary to attend training sessions shall be shared equally by the parties to this agreement, with the rate of remuneration to be in accordance with clause 5 herein.

4. Hearings

The cost of the Board and Secretary to sit to hear appeals and for the secretary to process and serve the necessary documents involved with an appeal shall be the sole responsibility of the municipality from which the appeal was lodged, with the rate of remuneration to be in accordance with clause 5 herein.

5. Rate of Remuneration

Board members and the Secretary shall be paid at the rate of \$25.00 per hour. A travel allowance shall be paid in accordance with rates approved by the Saskatchewan Public Service Commission. Any necessary meal expenses will be paid, not to exceed the meal allowance rates approved by the Saskatchewan Public Service Commission.

6. Payment of Expenses

The Rural Municipality of Nipawin No. 487 shall pay for all expenses related to the operation of the District Board of Revision including the training of its secretary and members and recover the costs from the participating municipalities in accordance with this agreement.

7. Term of Agreement

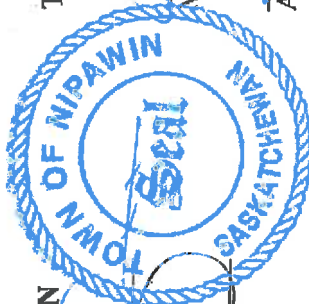
This Agreement shall come into force and be effective upon the signing and sealing of the municipalities and shall be continuous. Any party to the Agreement may withdraw from the District Board of Revision by giving written notice to the other municipalities by November 1st of any year.

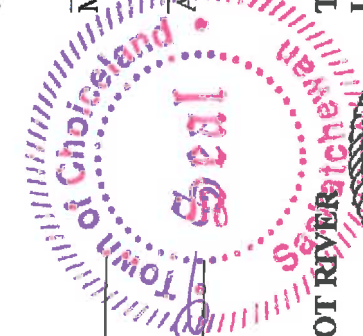

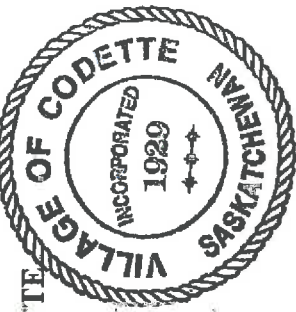

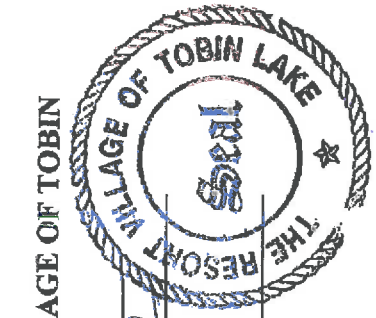
